The Seal of the District shall be circular in shape with the words "The Uintah Water Conservancy District" inscribed around the perimeter of the Seal and the words "Corporate Seal Utah" inscribed within the center of the Seal.

**' 1203 Principal Place of Business**

The principal place of business and office of the District shall be in the building at 78 West 3325 North, Vernal City, Utah, which building shall be known and designated as the "District Headquarters."

**' 1204 Mission and Objectives of District**

**' 1204.01 Mission**

The mission of the District is to:

- (a) Acquire, develop, conserve and where necessary preserve water resources, identified as necessary to accomplish the purposes of the District;
- (b) Construct, operate and maintain facilities associated with these water resources and such other facilities as are necessary for the functioning of the District;
- (c) Preserve, where necessary, stream and/or watershed ecosystems to maintain water quality standards and aquatic ecosystem balances; and
- (d) Maintain responsible management of the District's physical facilities, financial, water and human resources.

**' 1204.03 Policy**

It is the District's policy to develop and conserve water supplies for the benefit of its inhabitants through the most cost effective and environmentally prudent methods. The water supplies shall be developed for any and all beneficial uses consistent with the mission and statutory authority of the District. In furtherance of this policy, water rights shall be acquired by any lawful means and used for any lawful beneficial use, including without limitation, irrigation, municipal, industrial, hydropower generation and in stream flows.
