FINDINGS OF FACT, CONCLUSIONS OF LAW AND DECREE ORGANIZING, ESTABLISHING AND INCORPORATING UINTAH WATER CONSERVANCY DISTRICT.

Civil No. 3482

The petition for the organization of the Uintah Water Conservancy District filed with the Clerk of this Court on the 25th day of September, 1956, having come on regularly to be heard this 27th day of November, 1956, and the Court having considered the petition and the evidence introduced in support thereof, Hugh W. Colton and Whitney D. Hammond, appearing as attorneys for the petitioners, and no one appearing in person or by attorney protesting the granting of said petition, makes, files and enters the following

### FINDINGS OF FACT:

- 1. That due and legal notice of the hearing of said petition has been given in accordance with law and the order of this Court, and proof of publication having been filed of said notice.
- sufficient to pay all expenses connected with the proceedings in case the organization of this District be not effected, has been filed with the Clerk of this Court, which said bond has been approved by the Court.
- 3. That no petition has been filed in the office of the Clerk of this Court protesting the creation of said District.
- 4. That the petitioners in said petition so filed, as aforesaid, are desirous of organizing, establishing and incorporating a water conservancy district to include all of Uintah County, excepting that portion of the West side of Uintah County described as follows:

Doginning at a point on the boundary line between Uintah and Duchesne Counties where the township line between townships 2 South and 3 South, Uintah Special Base and Maridian intersect the said county boundary line, thence East along this Township line to the Uintah River, thence northwesterly along the Uintah River to a point where the Uintah River intersects the county boundary line between Uintah and Duchesne Counties in Section 10,

Township 1 North, Range 1 West, Uintah Special Base and Heridian, thence South along the boundary line between Uintah and Duchesne Counties to the place of beginning,

including in said district all the property of Vernal City and Maeser Town, within the said Uintah County.

- 5. That all of Wintah County is within the jurisdiction of this Court.
- 6. That the name of the district shall be Uintah Water Conservancy District.
- 7. That the signers of said petition are not fewer than twenty percent (20%) of the land owners in that portion of Uintah County to be included in the said district and not fewer than five percent (5%) of the landowners embraced in the city limits of the incorporating city and town situated in the proposed district.
- 8. That opposite the name of each of the signers of said petition is listed the land owned by said signer, together with the improvements thereon, has an assessed value of not less than three hundred dollars (\$300.00), and the assessed value of all irrigated land within the district is \$1,730,840.00.
- 9. That the property within the district will be benefited by the accomplishment of the purposes enumerated in Section 4, Chapter 9, Title 73, Utah Code Annotated, 1953, to-wit: by conserving, developing and stabilizing supplies of water for domestic, irrigation, power, manufacturing, municipal and other beneficial uses as contemplated in said Act.
- 10. That the organization, establishment and incorporation of said
  District is for the purpose of conserving, developing and stabilizing supplies
  of water for domestic, irrigation, power, manufacturing, municipal and other
  beneficial uses, and for the purpose of constructing drainage works and for all
  other purposes authorized by law, with the power to contract with the United
  States of America, the Secretary of the Interior thereof, and or any other
  officer or agency of the United States of America as provided in that certain
  Act of Congress of the United States, entitled " the Act of April 11, 1956,
  84th Congress 2nd Session," and any acts amendatory thereof or supplementary

thereto, and with power to contract with the United States under any acts of Congress that may hereafter be enacted relating to any of the purposes for which said district is organized, established and incorporated.

- 13, That this Court has original and exclusive jurisdiction co-extensive with the boundaries of said water conservancy district and of the land and other property included in said District and affected thereby, without regard

to the usual limits of its jurisdiction, and that all of the questions of the Court's jurisdiction to hear and determine and act upon the petition herein and to organize, establish and incorporate the same are hereby determined to be in favor of the organization, establishment and incorporation of Uintah Water Conservancy District.

From the foregoing Findings of Fact, the Court now makes, enters and files the following

### CONCLUSIONS OF LAW:

That said petitioners are entitled to the Decree of this Court organizing, establishing and incorporating the Uintah Water Conservancy District in accordance with the petition herein, with all the rights, privileges and powers prescribed by law, and in accordance with the foregoing Findings of Fact.

And the Court having made, entered and filed its Findings of Fact and Conclusions of Law, wherein the Findings of Fact and Conclusions of Law are separately stated,

IT IS ORDERED, ADJUDGED AND DECREED

1. That the district includes all of Uintah County, excluding only the following described area:

Beginning at a point on the boundary line between Uintah and Duchesne Counties where the Township line between Townships 2 South and 3 South, Uintah Special Base and Meridian intersect the said county boundary line, thence East along this Township line to the Uintah River, thence northwesterly along the Uintah River to a point where the Uintah River intersects the county boundary line between Uintah and Duchesne Counties in Section 10, Township 1 North, Range 1 West, Uintah Special Base and Meridian, thence South along the boundary line between Uintah and Duchesne Counties to the place of beginning,

including all the property of Vernal City and Maeser Town, be and is hereby declared to be organized, established and incorporated as a water conservancy district.

2. That the corporate name of said district shall be and is the Uintah Water Conservancy District and said district shall be and is a political subdivision of the State of Utah and a body corporate with all the powers of a public and municipal corporation for the purpose of conserving, developing

and stabilizing supplies of water for domestic, irrigation, power, manufacturing, municipal and other beneficial uses; for the purpose of constructing drainage works and for all other purposes authorized by law, with the power to contract with the United States of America, the Secretary of the Interior thereof, or any other officer or agency of the United States of America as provided in that certain Act of Congress of the United States, entitled " the Act of April 11, 1956, 84th Congress 2nd Session," and any acts amendatory thereof or supplementary thereto, and with power to contract with the United States under any acts of Congress that may hereafter be enacted relating to any of the purposes for which said district is organized, established and incorporated, and with all the rights, privileges and powers of such District prescribed by law.

- 3. That the principal office and place of business of said District shall be located at Vernal City, Uintah County, State of Utah.
- 4. That this Court shall have and has original and exclusive jurisdiction of said District coextensive with the boundaries of said water conservancy district and of the land and other property included in said District or affected by said District, without regard to the usual limits of its jurisdiction, and that all of the questions of the Court's jurisdiction to hear and determine and act upon the petition herein and to organize, establish and incorporate the same are hereby determined to be in favor of the organization, establishment and incorporation of said District.
- 5. That there shall be a Board of seven directors of the said District, one director for each district and the term of office for the said Board of Directors shall be as hereinafter shown for the initial term and thereafter shall be for a period of three years:
