RESOLUTION

WHEREAS, the Jensen Unit of the Central Utah Project was authorized by the Congress of the United States in 1956; and

WHEREAS, the U. S. Bureau of Reclamation has completed the planning for the Jensen Unit and is now ready to commence construction; and

WHEREAS, a repayment contract was executed by the Board of Directors of the Uintah Water Conservancy District on June 3, 1976 to repay the repayable costs of the project; and

WHEREAS, the Uintah Water Conservancy District and the U.S. Bureau of Reclamation have assisted water users in executing petitions to acquire irrigation water allotments from the Jensen Unit.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Uintah Water Conservancy District in an official meeting, held on #-2Z-77 does hereby approve the following petitions (as ammended) for irrigation water supplies and orders that the petitions be granted in the total amount of 2,700 acre feet and further directs the Officers of the District to sign the allotment petitions on behalf of the District.
